



## 2020 Canterbury Park Participation & Shipping Incentives

In conjunction with the Minnesota HBPA, Canterbury Park is happy to offer three separate shipping and participation incentives during the 2020 Live Racing Season.

### **Guaranteed Purse Payments during the 2020 Season tiered by Purse Level**

In 2020, every starter in all races will be guaranteed the following minimum payments with the intent of providing purse money to cover a greater percentage of the cost to start a horse.

<b>Purse Level</b>	<b>Guaranteed Purse Earnings</b>
Up to \$14,999	\$250
\$15,000 - \$29,999	\$375
\$30,000 - \$49,999	\$600
\$50,000 - \$99,999	\$1,000
\$100,000 - \$199,999	\$2,000
\$200,000 & Up	\$4,000

### **\$250 Additional Participation Incentive for all Thoroughbreds in Condition Book #1**

Additionally, every thoroughbred starter in all overnight races during the first Condition Book (May 15 – May 25) will earn an additional \$250 participation bonus in every start; therefore, guaranteeing all thoroughbreds a minimum of \$500 per start between May 15 and May 25. Please note, this participation incentive will be paid for each start a thoroughbred makes in an overnight race throughout the entirety of Condition Book #1\*.

\*\*This incentive is included in the advertised purse of all races in Condition Book #1 as a \$2,500 Starters' Bonus (as if it 10 horse field drew into the race). This figure will be adjusted after the draw to match the actual number of horses starting in the race (i.e. a six horse field will show a \$1,500 Starters' Bonus, an eight horse field would show a \$2,000 Starters' Bonus and a 12 horse field would show a \$3,000 Starters' Bonus). Bonus money will be paid out by starter and will be adjusted for any late scratches.

### **\$250,000 Canterbury Park Shipping Loan Program**

Returning in 2020, Canterbury Park will again offer a shipping loan program to qualified applicants who arrive prior to the start of the 2020 Live Racing Season. Shipping Loan Applications will be due with stall applications and will be reviewed by the stall allocation committee.

Upon review, the committee will authorize up to \$25,000 per owner to cover the cost of horse transportation to Canterbury Park. The loan will be repaid through an agreement between the successful applicant and Canterbury Park. Full terms and conditions can be found on the reverse side.
