



2022 Canterbury Park Shipping & Participation Incentive Programs

In conjunction with the Minnesota HBPA, Canterbury Park is proud to offer four separate participation and/or shipping incentives during the 2022 Live Racing Season.

Newly Revised: Up to \$1,250 Participation Incentive in All Thoroughbred Overnight Races During the Month of May

Every thoroughbred starter in all overnight races during the Month of May (May 18 – May 29) will earn a \$1,000 participation bonus in each start. However, any horse making their most recent start at a racetrack located more than 1,500 miles from Canterbury Park (notably, Golden Gate Fields, Gulfstream Park, Tampa Bay Downs or Turf Paradise) will receive \$1,250 in each start.

Please note, this participation incentive will be paid for each start a thoroughbred makes in an overnight race during the month of May (i.e. a starter isn't limited to a single payment) and is in addition to their regular purse earnings.

\$1,000 Illinois-Based Thoroughbred Participation Incentive through July 17, 2022

All thoroughbred starters that ran in Illinois in 2021-2022 (defined as the horse having made at least one start at Arlington Park, Hawthorne Race Course and/or Fairmont Park from January 1, 2021 – May 17, 2022) but have not previously started at Canterbury Park will be eligible for a \$1,000 bonus in their first start of the 2022 Canterbury Park Season through racing on July 17, 2022 at which time this incentive will expire.

This incentive will be in addition to the \$1,000 participation bonus throughout May (i.e. a horse meeting the above conditions would be eligible for \$2,000 during its first start in May at Canterbury Park).

Guaranteed Purse Payments during the 2022 Season tiered by Purse Level

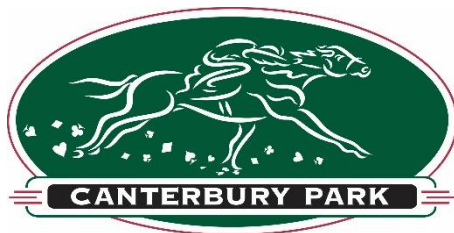
In 2022, every starter in all races will be guaranteed the following minimum payments with the intent of providing purse money to cover a greater percentage of the cost to start a horse.

Purse Level	Guaranteed Purse Earnings
Up to \$14,999	\$175
\$15,000 - \$29,999	\$250
\$30,000 - \$49,999	\$400
\$50,000 - \$99,999	\$650
\$100,000 and Up	\$1,250

\$250,000 Canterbury Park Shipping Loan Program

Returning in 2022, Canterbury Park will again offer a shipping loan program to qualified applicants who arrive prior to the start of the 2022 Live Racing Season. Shipping Loan Applications will be due with stall applications and will be reviewed by the stall allocation committee. Upon review, the committee will authorize up to \$25,000 per owner to cover the cost of horse transportation to Canterbury Park. The loan will be repaid through an agreement between the successful applicant and Canterbury Park. Full terms and conditions can be found on the reverse side.
