## **Super Satellite Handicapping Contests For Dec. 21 One Shot NHC Qualifier**

Official Rules & Regulations

**Summary:** 

Beginning October 3, 2024, \$10 Super Satellite contests will be held each week through December 14 that will qualify players for an entry fee to the One Shot NHC Qualifier Contest on December 21, 2024 which will award entry, \$400 for travel expense, and accommodations to the National Horseplayers Championship in 2025.

Players will be allowed to play in three \$10 Super Satellite contests EACH series choosing from Thursday, Friday, and/or Saturday.

In each series each week the highest individual score from each three-day contest period determines the winner of that series. Three selected tracks (eight races at each track) are offered each day of the series. Players can enter three contests in one day (no more than one entry per track per day) if they so choose but total entries for a contest series cannot exceed three. Each entry is \$10 per contest track with a limit of three per series. Each week, one winner for every 10 entries will receive an entry to One Shot NHC Qualifier Contest on December 21, 2024. The entry is valued at \$100. Winners must provide \$50 NHC Tour ID to play on December 21. NHC ID is not included in prize.

The Super Satellite contest format requires entrants to select one horse in each of the eight contest races and submit the selections before entry deadline. Points will be awarded for selections based on the official mutuel payoffs based on a mythical \$20 across-the-board wager. Entrants must be 21 years of age or older.

The highest score from each three-day contest period will determine the winner. For example, Player A may have the highest score of 800 on Thursday of the contest period but would not beat Player B who scores 900 points on the Saturday of the same contest period.

Scores will not be posted until the end of the contest period.

**Duration:** 

The three-day contest periods will begin on Oct. 3, Oct. 10, Oct. 17, Oct. 24, Oct. 31, Nov. 7, Nov. 14. Nov. 21, Nov. 28, Dec. 5 and Dec. 12.

**Entry:** 

Official entry forms will be available at the third level Information Center each contest day. Entrants must complete the entry form and submit it along with the \$10 fee prior to the entry deadline.

How to Play:

Each contest day, players can choose one of three selected tracks to play. Each contest track will have eight contest races. Each entry form will list the tracks and contain the contest races from the tracks. Players pick one track and then one horse in each race. Players will be awarded the amount of points that equals the total dollar amount of the official mutuel return on their selections based on a mythical \$20 across-the-board wager. No changes will be allowed once entries have been submitted.

**Awarding Points:** 

Points will be awarded based on the official outcome of the race card at the contest track. Players will be awarded the amount of points that equals the total dollar amount of the official mutuel return on their selections based on a mythical \$20 across-the-board wager. For example: If a player's selection finishes first and the official mutuel results are as follows: \$6.00 to win; \$4.00 to place; \$2.40 to show, the player will receive 124 points. If a player's selection finishes second and returns \$15.00 to place; and \$8.80 to show, the player would receive 238 points.

The maximum point payoffs per race for win, place, and show will be capped in the following manner. The maximum points possible for win will be 600 points, for place 400 points; and for show 200 points.

The contest winner will be the player accumulating the most points in an individual contest over the three-day contest period.

**Results:** Official results are based on the official payouts.

Prize Structure: One winner for every 10 entries will receive an entry to One Shot NHC Qualifier

Contest on December 21, 2024. The entry is valued at \$100. Winners must provide \$50 NHC Tour ID to play on December 21. NHC ID is not included in prize. Extra entry fees from each period will be divided with 60% being paid to the player with the highest score that did not win a Dec. 21 entry each period; 40% will be aggregated over the entire contest span and will be paid as a bonus to the player that scores the highest individual contest score over the entire contest span. For example, with 11 entries there will be one winner receiving a \$100 entry; \$6 will be paid to the second highest scorer and \$4 will be added to the bonus pool. Twenty-one entries would result in two \$100 entry winners

with \$6 going to the third highest scorer and \$4 to the bonus pool etc.

In the event of a tie, the prizewinner will be the player selecting the most first place horses. If a tie still exists, the winner will be determined by a coin toss.

**Scratch:** In the event of a scratch, selections will be replaced with the wagering favorite.

**Cancellation:** In the event a card is canceled the following will apply: if the card is cancelled before the first race, that track will not

be used in the contest. If a partial card is cancelled, entry fees for that track will be refunded and no scores will be recorded. If a race is determined to be a non-wagering event and no mutuel payoffs exist, each player will receive for

that race the average per-race score from their other races combined.

**Posting Of Results:** Results will be posted at the 3<sup>rd</sup> level Information Center and at <u>www.canterburypark.com</u> the day following the

contest.

**Deadline:** All entries must be submitted prior to first contest race at each track.

Eligibility /

Ties:

**Ineligibility:** The following are **ineligible** to participate in this tournament: anyone under the age of 21; anyone

forbidden to play the horses at Canterbury Park.

Judging and

**Disputes:** The management of Canterbury Park reserves the right to interpret all questions and conditions in regard to

this event, without claim for damages or recourse of any kind. All questions and definitions not covered explicitly in these rules will be decided by the management of Canterbury Park, with those decisions to be

final.

**Affidavits**: Affidavits confirming compliance with contest rules will be required of all winners. Any winner found to

be in violation of contest rules will be considered ineligible and the prize will be returned to inventory for

distribution to an eligible patron in a consolation drawing.

Taxes: Contestants are responsible for taxes resulting from prize winnings. Canterbury Park will provide a 1099

at the end of the year. Note: a social security number is required with signature on affidavit.

Handicapper of the Year Points: The player with the highest score each contest period will receive one Handicapper of the Year

point. The player with the highest individual contest score from the entire contest span will receive one Handicapper of the Year point. For more information on Canterbury's Handicapper of the Year contest
