### **No HISA Fees for Canterbury Park Horsepeople**

In partnership with the Minnesota Racing Commission, Canterbury Park is proud to announce there will be no HISA per start fees passed on to horsepeople in 2025. The MRC and Canterbury Park are once again working together to cover this cost.

### **Guaranteed Purse Payments during the 2025 Season Tiered by Purse Level**

In 2025, every starter in all races will be guaranteed the following minimum payments with the intent of providing purse money to cover a greater percentage of the cost to start a horse.

<b>Purse Level</b>	<b>Guaranteed Purse Earnings</b>
Up to \$14,999	\$175
\$15,000 - \$29,999	\$250
\$30,000 - \$49,999	\$400
\$50,000 - \$99,999	\$650
\$100,000 and Up	\$1,250

### **\$250,000 Canterbury Park Shipping Loan Program**

In conjunction with the Minnesota HBPA, Canterbury Park is proud to offer a shipping loan option for the 2025 Live Racing Season.

For the 2025 Live Racing Season, Canterbury Park will offer a shipping loan program to qualified applicants who arrive prior to the start of the 2025 Live Racing Season. Shipping Loan Applications will be due with stall applications and will be reviewed by the Stall Allocation Committee. Upon review, the Committee will authorize up to \$1,000 per horse, with a maximum loan of \$20,000 per owner, to cover the cost of horse transportation to Canterbury Park. The loan will be repaid through an agreement between the successful applicant and Canterbury Park. Full terms and conditions can be found on the reverse side.

*Please Note: This is a loan requiring repayment and not a pre-paid starter incentive.*
